\*For opening a PayMan account for individual clients who are not citizens of the Republic of Bulgaria, an additional one-time fee for client review and identification is required. This fee may vary and is determined by agreement, depending on the specific requirements and complexity of the documentation. For opening a PayMan account for legal entities registered outside the territory of the Republic of Bulgaria, an additional one-time fee for client review and identification is also required. This fee may vary and is determined by agreement, depending on the specific requirements and complexity of the documentation.

## Conditions:

- 1. When entering into a contract with a client (individual or legal entity), a PayMan account under the "Free" Subscription Plan will be opened.
- 2. Each client can change their Subscription Plan at any time through the PayMan App.
- 3. Subscription Plan changes can be made only once per calendar month.
- 4. When switching from the "Free" Subscription Plan to a plan with a monthly fee, a one-time "Subscription Plan Change" fee applies. The new Subscription Plan takes effect immediately after the fee is paid.
- 5. When changing the Subscription Plan, the monthly fee for the new plan is due from the first day of the calendar month following the month of the change. The new plan, along with applicable fees, will take effect from the first day of the calendar month following the month of the change.
- 6. The monthly fee covers the entire calendar month, from the 1st to the last day of the month.
- 7. If a client fails to pay two consecutive monthly Subscription Fees for their selected plan, "PayMan Group" LLC has the right to immediately, automatically, and without the client's consent or prior notice, change the client's Subscription Plan to the Free plan.

This document, "PayMan Fees and Limits," is effective from September 5, 2024.
